ORDER

Whereas Telugu School society (Regn No. S-3178/1966-67) Sector-2, R.K Puram New Delhi-110022 has submitted an application dated 12/11/2015 for dissolution of the Telugu School Society (Regd.) and requested for approval to handover the management of Telugu School, sector 2 R.K Puram, New Delhi to Andhra Education Society (Regd.), Delhi, No. 1, Deen Dayal Upadhyay Marg, New Delhi-110002.

And whereas, Telugu School society has convened a meeting of the special general body for dissolution of society on 26/07/2015 and it was unanimously decided through resolution of the special general body meeting to dissolve the society and the same be handed over to Andhra Education society and also to inform the Registrar of Societies for necessary approval in the matter.

And whereas, Andhra education society vide its letter dated 10/02/2016 has stated that they have received the request letter from the secretary, Telugu School society for taking over the responsibility of the management/administration of the Telugu School both primary wing (aided by SDMC) and secondary wing (aided by Govt. of NCT of Delhi) and they accepted the same as per their rules and regulations.

And whereas, the Registrar of society has gone through the documents submitted by Telugu School Society and since the procedure for dissolution as per Societies Act has been complied, Registrar of Societies hereby approves the dissolution of Telugu School Society. The Registrar of Societies also approves the request of Telugu School Society made under section 14 of the Act and the Andhra Education Society has to complete all the codal formalities as per the Act and obtain necessary approval from concerned Departments to bring into effect the same.

It is ordered accordingly.

MEMORANDUM

Constitution of India under Article 30(1) provides rights to all minorities, whether based on religion or language to establish and administer educational institutions of their choice.

Delhi School Education Rules, 1973 contain following provisions for the minority schools:-

Proviso to Rule 59 - Scheme of management of recognised schools

"In the case of a minority school, such members of the managing committee, as are required by this rule to be elected, may, instead of being elected, be nominated by the society or trust by which such unaided minority school is run:

In the case of a minority school, the educationist to be nominated by the director shall be a non-official who shall belong to the minority by which the school is established and run:

Nothing in sub-clause (iv) (i.e. nomination of two persons by the Advisory Board) shall apply to a minority school:

The members nominated under clause (v) (i.e. two members nominated by the Director) shall not be entitled to take part in the management of the minority school and shall function as advisers and observers to put forward the views of the Government in the meeting."


Rule 96 (3-A) - Recruitment

"In the case of an aided minority school, the educationists nominated under paragraph (iii) of clause (a) of sub-rule (3), persons nominated by the Director under paragraph (iv) of clause (a) of sub-rule (3), educationists nominated under paragraph (iv) of clause (b) of sub-rule (3), an expert nominated under paragraph (v) of clause (b) sub-rule (3), a person nominated under paragraph (iii) of the clause (c) of sub-rule (3), officers nominated under paragraph (iv) of clause (c) of sub-rule (3), a person nominated under paragraph (iii) of clause (b) of sub-rule (3), shall act only as advisers and will not have the power to vote or actually control the selection of an employee."

Proviso to Rule 98 - Appointing Authority


"The provision of the sub-rule (sub-rule 2 i.e. approval of the Director) shall not apply to a minority aided school."

The above provisions of the Delhi School Education Rules, 1973 are reiterated for information and compliance by all concerned.
